Charlie speaks to many of us while working in his yard and from there he also keeps an eye on the cars running the stop signs or mistaking Cedar Circle as a racecourse.

Dorn Wagner, treasurer, is trying to collect the dues from all of us. For many, dues collection efforts are the time to vent anger and frustration with the neighborhood or the board. We want to encourage anyone who feels that the neighborhood and the association it represents are not worth the mandatory membership fee of \$15 per year, to speak up before collection time and to make a difference through suggestions and constructive criticism. When Dorn tried to find volunteers who could act as "block captains" and board liaison for their section of the street or block, we found little interest. # Stormwater and Flooding

Several residents in the 2100 block of Fernglen have experienced standing water and flooding during last summer's heavy rainstorms. I visited two households and contacted the stormwater section of the Department of Public Works in Baltimore County and reviewed the site conditions with a field representative. It appears that the natural wooded buffer (continued on page 3)

between Westerlee and Pleasant Valley once worked as a Stormwater drainage basin directing sheetflow down towards a culvert underneath Cedar Circle at its western end. However, leaves, grass clippings and the natural decay of trees and branches seem to have built up over time until the waterflow was altered, keeping the stormwater from running off at the rear of the yards facing the buffer. Additionally it appears that in one case vegetation had been removed from a rear yard.

The County stated that regrading the buffer is not an option, since many mature trees in that buffer would be jeopardized. The Department of Natural Resources, who maintains the buffer, promised that fallen trees and such obstacles will be removed.

Beyond that we can only advise affected neighbors to avoid depositing yard waste in the buffer to keep drainage channels open that can discharge water into the buffer. Building dams or obstacles against the flow from a neighbor who sits on higher ground is not permitted. Open discharge of downspouts within 10' feet of the property line are not permitted either. Roof water should be directed to the street or the rear of the yard. Planting beds, shrubs, and trees will retain rainwater much better than lawns and are encouraged because they reduce run-off.

#### Windsor Mill Middle School Construction

We're certain you know that there is a new middle school under construction on Windsor Mill Road (west of Rolling Road, near Old Court Road). Windsor Mill Middle School is scheduled to open in 2006. As we travel past the site, it appears that construction is moving along well.

"The last piece of our school construction request is the new Windsor Mill Middle School. Building this new middle school will relieve overcrowding at five Baltimore County middle schools. Schools like Southwest Academy, which alone has 222 more students than it was designed to serve. Our funding request for Windsor Mill is 6.7 million dollars, money that will take Baltimore County students out of parking lot trailers and put them in new classrooms."

# Construction Plans Must be Submitted for Approval

Our covenants state that all <u>external</u> changes to our homes or lots must be approved by the Board of Directors, in order to maintain the integrity of the architecture and landscaping in Westerlee:

"No garages, outbuildings, fences or other structures shall be erected without prior permission of Westerlee Community, Inc., its successors or assigns, or its duly appointed agent, and no building shall be built closer to the front street than forty (40) feet, no closer to the side street than twenty-five (25) feet."

For that reason, an Architectural Review Committee studies all plans and submits their findings and recommendations to the Board only at the regular quarterly meetings. That means that you must plan ahead if you wish to add an addition, a shed, or even a fence. Architectural plans must be submitted four weeks before a board meeting to give the Architectural Review Committee and the Board adequate time to review the (continued on page 5)

# Westerlee Community, Inc. Abridged Board Meeting Minutes November 9, 2004

The meeting was called to order at 7:32 with Klaus Philipsen, Chuck Sprague, Dorn Wagner, Marilyn Maxwell, Tom Boyle, Sue Haines, Jim Holman, Flossie Johnson, Shirley Smith, and Charles Yingling, present and Pam Wright, Leyha Callender and Bettye Gray absent. Also in attendance were Chun and Brian Ok, and Richard Maxwell.

Since Brian and Chun Ok were present, the first order of business was to discuss their concern for the work a contractor has been hired to do on their house. They are pursuing any recourse that they may have against this contractor through the county and the courts.

The minutes of the August 3, 2004 Board meeting were approved.

DRAINAGE PROBLEM ON FERNGLEN WAY was discussed. There is an article written on this ongoing problem elsewhere in the newsletter.

THE TREASURER'S REPORT was read and approved. There was a beginning balance for the quarter of \$3703.64; income from dues and ads in the newsletter was \$130.60, and expenses for insurance, newsletter printing and a 2-year subscription for the new web site were \$446.17. The ending balance at 10/31/04 was #3388.07.

COMMITTEE REPORTS and recommendations were given by Klaus Philipsen (Architectural Review Committee), Shirley Smith (Code Enforcement), Dorn Wagner (Block Captains), Marilyn Maxwell (Newsletter and Web Site), Charles Yingling, Welcoming Committee.

RE: WELCOMING COMMITTEE: It was agreed that we should put notes of welcome in the newsletter, and that, in the future, a welcome basket should be given to each new neighbor.

GENERAL ASSOCIATION MEETING: March 10<sup>th</sup> was proposed, with March 8<sup>th</sup> and 9<sup>th</sup> as backup dates. We will give you the final dates in a timely manner.

REDLINE TRANSIT PLANS: plans for rail on Rolling Road have been discarded; Rapid Bus is still being proposed for Rolling Road in a designated lane.

#### **NEW BUSINESS:**

Charles Yingling reported that the WIDENING OF DLONG ROAD is in the works as part of the car dealer's agreement and that work is expected to start in 4 - 6 weeks.

The BUILDING OF TOWNHOUSES on the Hoffman Property and behind the homes from 2019 to 2029 Cedar Circle Drive is underway. We will try to keep you up to date on the progress and how the building project affects us.


