President's Letter

Dear Neighbors,

When this paper reaches you the election will be a thing of the past and I am sure, no matter where you stand, you will be glad that the campaign season is finally over and the country can come together again.

The Westerlee Board isn't oriented by party affiliation, of course, and has always addressed the matters at hand across different political opinions. Traffic, stormwater, covenants and zoning are certainly political but their practical application is so obvious that ideological ballast rarely stands in the way.

Zoning: Westerlee expressed a desire to protect current zoning in which Powers Lane is the divide between residential use to the north and commercial use to the south (except directly on Rolling Road). With the help of our Councilman Tom Quirk that line was held in the recently completed quadrennial big re-zoning process, in spite of pretty strong pressure from Antwerpen Automotive and its lawyers who wanted to bring commercial car storage to the open spaces north of Powers Lane. The lawyers may still file again for a variance and appeal the decision that the administrative law judge made in favor of the community even before the zoning was reconfirmed.

Catonsville ES: Slightly outside of our direct action area, but right in downtown Catonsville on Frederick Road the County plans to demolish the old Catonsville Elementary School. This isn't a matter in which Westerlee Inc. will likely take a position but if you are opposed to the demolition of such a fine building, like me, let our Councilman or me know.



Water Meters: Closer to home: As many may have noticed, new water meters have been installed in the community. Most of Baltimore County's water system is run by Baltimore City as a truly regional piece of infrastructure. Much of the aging infrastructure, what was once great is now falling apart. The old meters were often unreliable and the billing system a mess. Lately old water meters have been changed out into digital meters that can be read remotely and don't require peering down to the actual meter for a read-out. The City now has enacted a new billing system that is already in effect in the City and is expected to come to the County in April next year. The main changes are:

*Water/sewer bills will be issued monthly (no longer quarterly).

*DPW will no longer use minimum quarterly water fees to determine your water/sewer bill and rates are changing.

*DPW has created a website that allows you to calculate the anticipated monthly bill for a property based on meter size and consumption (http://publicworks.baltimorecity.gov/wat...). "Quarterly consumption" to be entered is per 100 CF of water consumed (you can

get this from your water bill). Note that the proposed monthly bill excludes administrative, Bay Restoration and Storm Water Remediation fees. These are estimated to be approximately \$20 monthly. More at http://publicworks.baltimorecity.gov/new.

Bicycle Network: Baltimore County is preparing bicycle routes on County streets to allow folks to ride bicycles more safely from neighborhood to neighborhood and also reach parks and trails without the need for loading a bicycle first into a car to get to a trail. The proposed maps were recently shown at an open house at Johnnycake Middle School. The focus was on the so-called Security-Ingleside Loop, phase one and two which connects neighborhoods to Leakin Park. Bicycle lanes and sharrows are proposed for a signed bike route (PDF) that will link residential communities with the Gwynns Falls Trail. The roads included as part of the route are Ingleside Avenue, Johnnycake Road, Crosby Road, Pleasant Valley Drive and Chesworth Road. Other destinations along the route include Western Hills Park, Westview Park and Southwest Academy. Engineering plans (PDF) depict the planned road markings and signage. Storm drain inlets are also being upgraded along the route to include bicyclefriendly grates. The work for Phase One of the project is primarily funded by a grant from the Maryland Bikeways Program. (4.5 miles). In a later phase there could be a connection from Pleasant Valley Road via the Nuwood right of way to connect across route 40 to the old trolley trail into Ellicott City. To realize this connection, the passage from Fernglen to Pleasant Valley would have to be made into an actual trail for biking and walking similar to the one already in place between Cedar Circle and Dlong/Powers Lane.

Board Initiatives: Upcoming Westerlee Board Initiatives include addressing drainage issues in the buffer strip between Fernglen and Pleasant Valley, addressing hazardous traffic conditions on Rolling Road at Cedar Circle, a re-energized effort of welcoming new community members with a "welcome package" of relevant information, improved methods of collecting dues with the help of our new Treasurer Rizwan Mahmoody who is taken this office over from Chris Goatee. Other Board plans include the usual activities such as the Holiday Decorations Contest, Westerlee Community gateway signs, the Annual Meeting, Dumpster Day, the Yard Sale and the Community Party.

Meeting Minutes Westerlee Community Association, Inc. October 18, 2016

The board meeting was called to order at 6:37 p.m.

Present were officers Klaus Philipsen (President), Wanda Richardson (Vice President) and Fred Hickok (Secretary) and board members Chris Goatee, Jacqueline Johnson, Fred Kirk, and Joe Reid and association member Nayna Philipsen. Absent were board members Rizwan Mahmoodi (Treasurer) and Lula Simon.

Bank Request: Chris reported that the bank has asked that the board members who were at the May meeting, where Rizwan was elected to be the new treasurer, sign a copy of the minutes so that his name may be put on the account for check signing privileges. The board members signed the copy of the minutes.

Committees: Wanda asked about members of the committees. The board members responded with the following list:

- Architectural Review: Klaus, Chris and Fred H.
- Block Captains: Wanda
- Code Enforcement: Fred K.
- Hospitality: Fred K.
- Social: Jacqueline, Wanda and Chris

Holiday Decoration Contest: The board decided that the judging would be done on Wednesday, December 21 and that the categories will be most over-the-top, most modern and creative, and most traditional. Chris remarked that only members who are current on paying dues will be eligible to win. Fred K. suggested taking pictures of the decorations for the winter newsletter. He also mentioned that he will be around to distribute the fall newsletter if it is ready by mid-November. Joe and Chris volunteered to cover for him if the newsletter comes out later.

Budget: The board decided that a full discussion of next year's budget will be put off until the winter board meeting when Rizwan can give a full report. Chris reported a current balance of \$8,694 said that usually between \$2,000 and \$3,000 is collected in yearly dues. Fred H. mentioned that \$1,500 is usually allotted for the community party. Nayna reminded the board of the possibility of legal fees. Klaus said that the Association has not paid for liability insurance for board members.

Newsletter: Klaus mentioned that articles for the fall newsletter should be sent to Pam Jarrell by October 21. Jacqueline said that she will send an article and pictures of the community party. Fred H. said that he will send minutes of this meeting and the article on celestial sights.

Fourth of July Flags: The board agreed with Wanda's suggestion about purchasing new American flags. Chris mentioned the alternative of telling the realtor who put up flags this year that all 166 homes should be served. She said that she could communicate that to the realtor.

Signs: Joe suggested looking into purchasing new signs for events. Fred K. said that he favors reusable signs. Chris suggested preprinted signs with changeable dates. She also said that she will check with Pam, who may know about signs. Nayna offered to check with a campaign worker who would know about signs. Fred H. reminded the board about also again looking into permanent community entrance signs.

Drainage Ditch: Fred K. asked about getting the County to clear

the drainage ditch that is in the wooded area north of Fernglen Way. He said that the ditch has filled in and does not divert rainwater from going down onto the Fernglen properties. Klaus said that he will contact Councilperson Quirk's office and ask that they send word to the Department of Public Works. Adjourned 7:35pm.

CELESTIAL SIGHTS

December 14 - Full Moon, Supermoon

The Moon will be at its closest approach to the Earth and may look slightly larger and brighter than usual. Early Native American tribes called this the Full Cold Moon because this is the time of year when the cold winter air settles in and the nights become long and dark.

January 12 - Full Moon

Early Native American tribes called this the Full Wolf Moon because this was the time of year when hungry wolf packs howled outside their camps.

January 12 - Venus at Greatest Eastern Elongation

The planet Venus reaches greatest eastern elongation of 47.1 degrees from the Sun. This is the best time to view Venus since it will be at its highest point above the western horizon in the evening sky.

February 11 - Full Moon

Early Native American tribes called this the Full Snow Moon because the heaviest snows usually fell during this time of the year.

March 12 - Full Moon

Early Native American tribes called this the Full Worm Moon because this was the time of year when the ground would begin to soften and the earthworms would reappear.
