President's Letter

Dear Neighbors,

Life in Westerlee is usually a peaceful affair. Except when the large share of nature which we luckily have in our community, reminds us of who is boss. The usual disruption from severe weather comes from falling trees and the toll they take on our above ground powerlines. This year already saw its share of power outages thanks to heavy rains, soggy grounds and hefty winds. A few years back, BGE had done a pretty good job with line maintenance and clearing, but by now branches and trees have grown back and tangle with the lines yet again.

Water is another problem many neighbors have come to fear. Thanks to the high groundwater level, the poor drainage and the hilly terrain, water easily finds its way into Westerlee's basements. Power outages, failing sump pumps and downpours present a treacherous combination which easily wreck lower level club-rooms, storage spaces or in-home offices.

If it isn't the weather it is traffic and trash which get neighbors upset. Westerlee's traffic is certainly comparatively benign. I haven't heard of any serious crashes on our roads since I moved here in 1992, but smaller issues can become a nuisance, too. One of those are the large car transporter trucks that come from Mile One auto businesses through our neighborhood, clanging their metal trailers on our speed bumps. Westerlee Inc. ,your friendly homeowners association, has filed a request with the county to install signs prohibiting large trucks. However, success of such a petition is not guaranteed. Before traffic engineers install anything, they like to study it. If their observations don't find enough trucks, we won't get a sign, just like Fernglen Way doesn't get any speed humps.

Our Board expanded when additional members were elected at the last Annual Meeting in April. New board members are John Fox, John Herron, Pam Jarrell and Michele Snowden. Ms. Snowden has already petitioned for the installation of accessible curb ramps in the Chantilla area and Baltimore County promised her to install them. I tried to add curb ramps at Cedar Circle at Rolling Road, but haven't yet received the same green light for those. The

Summary of Westerlee Board Meeting Minutes - July 18, 2018

The board meeting was called to order at 6:33 p.m.

Present were officers Klaus Philipsen (President), Wanda Richardson (Vice President), Fred Hickok (Secretary) and Rizwan Mahmoodi (Treasurer), board members John Fox, Chris Goatee, John Herron, Pam Jarrell, Jacqui Johnson, Joe Reid and Michelle Snowden.

Introductions: Board members introduce themselves for the benefit of new members. There was a general discussion about the duties of the HOA, its legal standing and what services it provides.

Dues: In an effort to achieve better collection rates in fairness to all payment reminders will be mailed to all who have not yet paid. A group was formed to achieve this labor intensive task.

Community Party: Chris confirmed that the party will be on Saturday, September 22, from 3 to 7. Jacqui said that we are using the same caterer as last year, that set-up is at 12 and that residents are to bring desserts. Rizwan said that \$1500 has been budgeted for the party.

Dumpster Day: Klaus said that it will be from 8 to 12 on Saturday, October 20, and that Fred will transport paint and electronics to the acceptance site.

Newsletter: Pam asked that newsletter items be submitted by July 23. Rizwan suggested including the decision on the Mile West liquor store license and election results. Wanda said she will send the menu for the picnic. John F. said he will help with uploading newsletters to the web site. John H. suggested an article on home sales and purchases. Klaus said that a yearly

report about that should be presented at the annual meeting.

Code Violations: The board discussed recent code action through notifying residents via letter or via filing a code violation notice on the County website. Most common violations are unlicensed vehicles on the street or on private property, commercial vehicles parked on private property (excluding those called for repairs or services).

Flags: Klaus suggested that the spring newsletter should inform residents that block captains will set out flags before July Fourth and pick them up afterward.

Issues and Candidates: Klaus asked whether we should invite candidates to discuss our major agenda items such as a walking trail above Cedar Circle Drive, speed humps on Fernglen Way and Rolling Road traffic. It was decided to deal with this after the general election when the officials are definite.

Next Meeting: Monday, October 15, 2018.

Baltimore County Political Update By Klaus Philipsen

With the primaries under our belt, we will know with certainty that an era of Baltimore County government has come to an end. Both, the Republican candidate Al Redmer and the Democratic candidate Johnny Olszewski promise a very different way of governing. Both emphasize transparency. The unexpected death of former Executive Kevin Kamenetz and the narrow loss of Vicky Almond as a candidate promising the most continuity make the shift more accentuated. As for our Council district 1, Tom Quirk, the incumbent could keep his challenger Sheila Ruth at bay. However, the fact that she received over 40% of the vote and that the Baltimore Sun endorsed her and not him in spite of his solid work in our district and beyond, proves that the electorate has a soft spot for those who challenge the current way of doing business and that whoever was seen as refreshing challenger the last time around, can quickly become seen as the status quo.

The shock which the sudden death of Kevin Kamenetz who ran a respectable campaign for Governor also showed that, in the smoke of daily political battles, the larger accomplishments are often overlooked. At Kamenetz' memorial service members of all parties and factions came together to see a person who had worked hard to make the County better. The bruised egos calmed down in the face of the Executive's passing and began to express what they had liked in the man and his legacy. Sometimes one wishes it wouldn't take death to achieve the bigger view. Politics on all levels would benefit from it.

- August 12, 13 Perseids Meteor Shower. The Perseids is one of the best meteor showers to observe, producing up to 60 meteors per hour at its peak. It is produced by comet Swift-Tuttle, which was discovered in 1862. Best viewing will be from a dark location after midnight. Meteors will radiate from the constellation Perseus, but can appear anywhere in the sky.
- · August 26 Full Moon. This full moon was known by early Native American tribes as the Full Sturgeon Moon because the large sturgeon fish of the Great Lakes and other major lakes were more easily caught at this time of year. This moon has also been known as the Green Corn Moon and the Grain Moon.
- September 25 Full Moon. This full moon was known by early Native American tribes as the Full Corn Moon because the corn is harvested around this time of year. This moon is also known as the Harvest Moon. The Harvest Moon is the full moon that occurs closest to the September equinox each year.
- October 24 Full Moon. This full moon was known by early Native American tribes as the Full Hunters Moon because at this time of year the leaves are falling and the game is fat and ready to hunt. This moon has also been known as the Travel Moon and the Blood Moon.
- · November 17, 18 Leonids Meteor Shower. The Leonids is an average shower, producing up to 15 meteors per hour at its peak. The Leonids is produced by dust grains left behind by comet Tempel -Tuttle, which was discovered in 1865.
- November 23 Full Moon. This full moon was known by early Native American tribes as the Full Beaver Moon because this was the time of year to set the beaver traps before the swamps and rivers froze. It has also been known as the Frosty Moon and the Hunter's Moon.
