### Meeting Minutes

Westerlee Community Association, Inc. February 8, 2021

The board meeting was called to order at 6:35 p.m.

Present were officers John Fox (President), Wanda Richardson (Vice President), Fred Hickok (Secretary), Rizwan Mahmoodi (Treasurer), Klaus Philipsen (Past President) and board members Chris Goatee, John Herron, Pam Jarrell and Jacqui Johnson.

Minutes of December 7, 2020 Board Meeting: Approved **Holiday Decoration Contest:** Pam announced the 6 winners and Jacqui volunteered to deliver the gift cards.

**Annual Meeting:** After a discussion of possible postponement, the board voted to have a virtual meeting at 7:00-8:30 on either Tuesday, April 13 or 27, using Google Meeting, Webex or Zoom Meeting. Invite County and State representatives, County police and health spokespersons with focus on the pandemic and health information. Chris suggested better management of the politicians' reports.

**Election of board members:** John F., Chris, Wanda and Klaus volunteered to work on details.

#### 2200 Cedar Circle Drive:

John F. reported that the owners Steve and Lorraine Marroulis have submitted video documentation about rainwater runoff caused from a clogged drain in the buffer strip between Fernglen Way and Pleasant Valley Drive homes.

Rizwan noted that the house next door at 2128 Fernglen Way has had significant damage from strong currents of water flowing from the buffer strip. He suggested hiring a contractor to help clear away debris. Klaus said that the former partner of Fred Kirk has a team that might be hired for perhaps \$500. John H. suggested having Westerlee volunteers

working at the same time and volunteered to organize this effort.

**Rolling Road Traffic:**Klaus reported that there has been no official response.

Walking Path: Klaus reported that the issue is bouncing among several agencies. A response letter states that Westerlee would need to submit a more detailed plan to receive an easement for a trail and be responsible for construction and maintenance. He said that we would try to get a more detailed base plan and obtain a rough estimate of construction costs (possibly greater than \$5,000). He noted that the County offers grants for neighborhood improvements.

#### **Committee Reports**

**Welcome:** John H. reported that he gave material to new residents.

**Newsletter:** Pam gave March 7 as the deadline for submissions for the next edition. John H. volunteered to write about the buffer strip and water issue.

Yard Sale: Jacqui said that the committee will meet to make plans so that the event can be announced in the newsletter.

**Treasurer:** Rizwan brought up the issue of instituting a processing fee for the work of reporting to title companies during a sale. He and John F. will submit a more detailed proposal to the board for a vote.

The board meeting adjourned at 8:06.

## Committee Report Water Run-off to the Board of Directors

With authorization from the board, we met to view the water runoff issues with neighbors at the bottom of Fernglen Way.

The swale, between Westerlee and the neighbors on Pleasant Valley Dr., which belongs to the Balt Co Dept of Recs and Parks, is the source of flooding in the yards of a few properties on Fernglen and Cedar Circle (2200). The swale is saturated and has standing water in several places all the way up to the top of Fernglen. Fallen trees, leaves and branches cover the area as well as debris and trash.

The swale narrows as it approaches the drain that should take water under the Cedar Circle Street. The drain opening is partially clogged with leaves and debris. There is a trough prior to the drain that should funnel water to the drain, but it appears to be a higher ground such that the water settles and has created a new path toward Fernglen Way in heavy wet periods--by-passing the drain altogether. Neighbors have videos of this diversions in yards and toward basements.

The homes on Pleasant Valley Drive are dramatically higher than the swale which suggests that a lot of water is runoff from those properties.

The Board acknowledges that the entire community is built on a slope that sends water to the river; there has been an increase in dramatic weather events; adjacent residents have some responsibility to keep it clean and functional; and it is in our interest to assess the long-term consequences of water run-off mitigation both now and in the future. A committee was formed to assess the problem, if needed, get professional advice on short-term remediation; and mobilize the communities if there are clean-ups and the like that would help.

The swale itself is on County land and is not our ultimate responsibility. We will need neighbors supporting this effort.

- · April 27 Full Moon, Supermoon. Because this full moon is near its closest distance to the Earth, it may look slightly larger and brighter than usual. This was known by early Native American tribes as the Pink Moon because it marked the appearance of the moss pink, or wild ground phlox, which is one of the first spring flowers. This has also been known as the Sprouting Grass Moon, the Growing Moon, and the Egg Moon. Many coastal tribes called it the Fish Moon because this was the time that the shad swam upstream to spawn.
- May 6, 7 Eta Aquarids Meteor Shower. This is capable of producing up to 30 meteors per hour at its peak. It is produced by dust particles left behind by Comet Halley. It peaks this year on the night of May 6 and the morning of the May 7. Best viewing will be from a dark location after midnight.
- May 17 Mercury at Greatest Eastern Elongation. This is the best time to view Mercury since it will be at its highest point above the horizon in the evening sky. Look for the planet low in the western sky just after sunset.
- · May 26 Full Moon, Supermoon. This was known by early Native American tribes as the Flower Moon because this was the time of year when spring flowers appeared in abundance. This has also been known as the Corn Planting Moon and the Milk Moon.
- · June 24 Full Moon, Supermoon. This was known by early Native American tribes as the Strawberry Moon because it coincides with the peak of the strawberry harvesting season. This has also been known as the Rose Moon and the Honey Moon.
